

Some may not know it by that name as it has had several owners over the years, but the house was built by J.R. Wells, the first president of Anchor Milling Company in 1889.

## THE ST. LOUIS NATIONAL PERSONNEL RECORDS CENTER

On July 12, 1973, the top floor of the National Personnel Records Center (NPRC) in St. Louis was destroyed by fire, resulting in the loss of millions of military records. Because of these losses researchers and veterans have, in the past, been forced to use alternative sources as references for military service.

Today the NPRC has a new facility and restoration of damaged records is underway. If you have written for records in the past and were told that the requested records were "lost", it is possible they could have resurfaced or may do so in the future. It might be beneficial to request those records again.

Record requests can take anywhere from two hours to six months. Requests regarding medical benefits or that are death-bed related receive top priority. Social Security benefits and other types of requests are next in priority. Genealogy and medal research requests receive the least priority.

As of 2004, records that are 62 years past the date of final separation from the military are archived and become available to the public. Access to records less than 62 years past the date of final separation from the military are restricted under the Freedom of Information Act to the veteran or his/her immediate next-of-kin.
