

# HOW TO SAVE PHOTOS FROM MAGNETIC ALBUMS

We've known for a long time that magnetic photo albums are very bad for photos. The polyvinyl chloride plastic sheets and high-acid cardboard pages greatly increase the rate of photo deterioration. Below are some suggestions for saving these photos.

- Before doing anything else, take a photo of each page of the album.
- Carefully remove images from the album. It is best to loosen the print from the page using a microspatula. It is not recommended that you freeze the album or use solvents to try to remove the photos.
- Scan each photo on a flatbed scanner with a resolution of 600 DPI for prints at full color.
- Store individual photos that you have removed from the album in acid-free box or in an archivalquality album with acid free pages.
- Upload your digital copies of your photos to an online photo-book creation service such at Shutterfly
  or Snapfish and create your new album. Remember to add an information page with a short history
  about the book itself.
